Inspector Allo joined at 9.55am.

Councillor McDavitt said he would first ask Dr Watson to explain why the Western Corridor Implementation Plan had not been available before today's meeting.

Dr Watson said the implementation plan was a technical report and just prior to completion Transit New Zealand had further proposals about Mana Esplanade for consideration at today's meeting.

Councillor McDavitt said as today's meeting was primarily to consider a consultation process for the plan he thought the meeting should hear a presentation from Mr Brennand prior to a formal consideration of the document.

Councillor McDavitt said, if members agreed, he then proposed that the item lie on the table for further consideration at a date in early April. Councillor McDavitt said he would advise when the meeting could reconvene later in the morning.

Mr Brennand then gave a presentation.

A copy of the Plan was then circulated and members stopped for morning tea at 10.45am.

Ms Warren said a recent article in the City Voice suggested that Wellington City Council was considering policies contrary to the Regional Land Transport Strategy and asked what power the Regional Council had to oppose such initiatives.

Dr Watson said that the Wellington City Transport Strategy was not a statutory document but consistency with the Regional Land Transport Strategy was a condition for funding from Transfund. Dr Watson said the Regional Council could involve itself in statutory processes such as the District Plan if it so wished.

Councillor Hutchings, Wellington City Council, said the City Transport Strategy had not been finalised and the City Voice article had simply recorded comments from individual Councillors.

Councillor Barnard asked whether the Regional Council involved other parties in discussions before items reached the committee stage. Dr Watson said in most cases prior discussions were held with interested parties. Council tried to be inclusive in all its transport deliberations.
