Sylvia Jenkin, Cannons Creek Valley Protection Group

Sylvia Jenkin referred to the Cannons Creek Valley Protection Group Submission on the Annual Plan and summarised the main concerns of the Group. Sylvia Jenkin said the Protection Group wished to work closely with Council in enhancing the environment for Belmont Regional Park and especially in the Cannons Creek Valley. The protection group was now an incorporated friendly society (Friends of Maara Roa) and may be able to assist with funding as plans are advanced for the Cannons Creek Valley. Concern remained on the status of the land; a reserve designation preferred.

Following questions Councillor Werry said the Annual Plan Submissions had received a favourable recommendation and a decision would be made at the Council's Annual Plan meeting later in the week.
