RSW 367 Presentation – Farm Environment Award Trust

The Chairperson welcomed Bill Garland (Chairman, Farm Environment Award Trust), Peter Mourits (Marketing Manager, Ballance Agri-Nutrients), and Phillipa Crequer (Waikato Farm Environment Award Trust), to the meeting to address the Committee on the Trust's proposal to expand the Waikato model throughout other regions as a national competition. The concept was comparing sustainability of all farm types over 20 hectares, and the national competition required the commitment and support of regional councils.

Cr Buchanan indicated that the Farm Environment Award Trust's proposal fitted in well with the Council's sustainability focus and environmental education programme, and conveyed to the representatives that this would be further pursued with the respective officers in both the Environment and Wairarapa Divisions.
