Waikanae Floodplain Management-River Mouth

Councillor Turver asked whether the flood protection works at the mouth of the Waikanae River could be in any way be contributing to coastal erosion in the area. Mr Dick said the Regional Council's flood protection work was subject to a Resource Consent issued by the WRC Consents Department. Some monitoring had been undertaken which suggested that there was no evidence the works were contributing to coastal erosion. Nevertheless, it would be very difficult to prove that the works had no effect. Mr Dick noted that in his view other factors such as El Nino weather pattern changes were more likely to be significant.
