Dr Watson gave a presentation on the Land Transport Management Bill including the key purposes of the Bill, the special elements of interest to The Greater Wellington Regional Council, the parts of the Bill that effect the Regional Land Transport Committee, matters that still require clarification such as the future role of the Regional Land Transport Strategy and the alignment of the Land Transport Management Bill with the Local Government Act. Dr Watson also gave some personal views on the value of the Bill to Land Transport Development.
