- When will the Johnsonville and Melling Line studies be completed?
- Who is liable for cost overruns?
- What if the toll rail cost estimate is wrong?

Tony Randle tabled and distributed a written statement to reinforce the questions he was asking of Greater Wellington.

Councillor Evans thanked Mr Randle for his contribution.

- (1) Chris Horne congratulated Councillors for their success in the recent local body elections.
- (2) Mr Horne congratulated Council for the Quality Partnership Agreements with Wellington City and Hutt Valley and requested Greater Wellington to press harder for the implementation of the undertakings in the agreements.
