LC 72 **General**(1) **Councillor Turver:**

Advised the meeting of Environment Canterbury's proposal of a regional river park based around the Waimakariri River to achieve the community inspired goals and objectives of the Waimakariri Management Strategy.

(2) **Mr Gilbert:**

Suggested that the track standards used in the parks should be used for the river tracks, for example by the Otaki River.

The Otaki has many users and the management of often conflicting uses appears blurred to the Friends of the River.

Officers advised that the environmental plans of the rivers can be re-examined, and a paper provided to the Committee at a later date.

(3) **Councillor Greig:**

Outlined some plantings and meetings that she had attended - thanking staff for their assistance at the Whakatiki planting, the Honda/Te Marua planting, and the Stratton Street woolshed meeting.

Councillor Greig also advised how well the Greater Wellington parks brochures and maps were received when handed out at the various activities.

(4) **Councillor Aitken:**

Suggested that the Community and Public Health Services Advisory Committees and Disabilities Advisory Committees of the two local health boards be invited to meet with staff to learn about the parks activities and how they contribute to health and wellbeing.
