(2) Set (a) A differential targeted rate on all rateable rating units in the area of the Awhea-Opouawe Catchment Scheme on the following basis:

- up to 55% of the revenue required will be set based on land value. Land value best represents the extent of benefits received by landowners in the Scheme.**
- up to 55% of the revenue required will be set and assessed on rating units (whether or not as the principal use) for residential purposes, as a fixed amount per separately used or inhabited part of the rating unit. The fixed amount will be \$100 plus GST for the first inhabited part and \$50 plus GST for any further dwellings. Rating units which have no residential use will not be rated the fixed amount per separately used or inhabited part.**

- (2) Set (b) **A differential targeted rate on all rateable rating units in the area of the Mataikona/Whakataki Catchment Scheme on the following basis:**
- **up to 55% of the revenue required will be set based on land value. Land value best represents the extent of benefits received by the landowners in the Scheme.**
 - **up to 55% of the revenue required will be set and assessed on rating units (whether or not as the principal use) for residential purposes, as a fixed amount per separately used or inhabited part of the rating unit. The fixed amount will be \$15 plus GST. Rating units which have no residential use will not be rated the fixed amount per separately used or inhabited part.**

Concerning 4.2 – Catchment Management - BioWorks Business Plan

Members discussed the issue of external contractors tendering for work in the Wellington region. The matter of Target Pests winning GW contracts was discussed and the question of BioWorks tendering for work outside the Wellington region.

RSW 117 General Business

- (1) Mr McQueen enquired as to progress with the Wairarapa Irrigation Project Study.

It was noted that Go Wairarapa was currently working with Meridian although progress was moving somewhat slow. GWRC was maintaining its interest with the possibility of flow work being undertaken in one of the valleys to gauge whether there is sufficient water available to build a dam.

The issue now was whether there was sufficient interest from end users to get a scheme underway which would be a significant change to the traditional farming community on the flats.

- (2) Mr Dalziell enquired as to whether additional speaking time could be granted to submitters during the LTCCP submission process. Mr Dalziell said that the 5 minutes allowed each speaker did not give credit to submitters wanting to establish a relationship with the Council and considered a further extension of time was appropriate.

- (3) Mr Dalziell commented that further investment needs to be given to soil conservation in the region's 380,000 hectares of hill country of which 87,000 hectares is erosion-prone.

Cr Buchanan indicated that the Council would be addressing the level of investment issue through its integrated catchment management approach to managing resources in the region.
