RSW 168 Wairarapa Hill Country Liaison Group

Members noted that a public meeting had been held on 21 September 2006 following extensive damage during the July flood events to the Wairarapa hill country. Outcomes from the public meeting had been requests for more poplar and willow poles, additional staff resources, and a desire to form a Wairarapa Hill Country Liaison Group.

Mr Cameron said that there was widespread interest for setting up a liaison group and its formation was about future partnerships and a vision for a more resilient hill country.

Mr Dalziell complimented officers on the report and stated that the formation of the group will enable the bringing together of rural concerns to one group. This was a very positive start and will help with the integrated catchment schemes to be implemented in the future.

Cr Buchanan indicated he was totally supportive of the formation of a hill country liaison group and said that there was an opportunity to take a national lead towards a formal integrated catchment approach.

Lake Wairarapa Regional Park Project

Mr Dalziell asked for information on the costs associated with the Lake Wairarapa Regional Park project. He said that no discussions had taken place with the Committee and enquired as to what expenses would be involved with the setting up of the wetland.

Cr Buchanan indicated that the figures in the LTCCP were indicative only until work on what form the regional park would take was completed. The 2007/08 draft Annual Plan included \$50,000 for set up work with the Department of Conservation. Once this work has been completed a better idea will be known as to what the costs will be and the matter will then be brought back to the Committee for discussion. It was noted that DoC were willing to work closely with GW.
