## **CDEM Group Appointments**

### **1. Purpose**

To request the Wellington Region CDEM Co-ordinating Executive Group (CEG) to recommend to the Wellington Region CDEM Group the appointment of officers to a number of positions that have become vacant from staff changes.

### **2. Background**

Legislation requires a CDEM Group to appoint, either by name or reference to the holder of an office, a suitably qualified and experienced person to be the Group Controller for its area (S.26 (1) of the CDEM Act 2002) and to appoint at least one suitably qualified and experienced person to perform the functions and duties, and exercise the powers of the Group Controller if they are absent from duty for any reason (S.26 (2) of the CDEM Act 2002).

S.27 (1) of the CDEM Act 2002 states that a CDEM Group may appoint 1 or more persons to be a Local Controller, and direct that person or persons to carry out any of the functions and duties of, or delegated to, that Group's Group Controller and to exercise the powers of Controllers in the area for which the Group Controller is appointed, including, but not limited to, the powers in sections 86 to 94.

Appendix 4 of the Group Plan lists the statutory and non-statutory appointments made by the CDEM Group to give effect to its structural arrangements. These positions are for Group Controller (and alternates), Group Recovery Manager (and alternate), Local Controllers (and alternates), Local Recovery Managers and Group Lifelines Co-ordinators.

### 3. Group appointments in the CDEM Group Plan

As a result of staff changes at territorial authority level and a re-structure of the Greater Wellington Regional Council towards the end of 2005, new appointments to some positions are required. These positions are Group Controller, Alternate Group Controller, Local Controller, Group Recovery Manager, Local Recovery Manager and Alternate Lifelines Co-ordinator positions.

The tables below show the new appointments that are being recommended in italics. Unchanged appointments are also shown:
