Members were given a background on the development works programme established 10 years ago and noted that since that time major floods had occurred in 2004 and 2006 which had changed priorities. The Lower Wairarapa Valley Development Scheme

Advisory Committee had reviewed the programme and supported the proposed amendments.

Members raised issues as to the dynamics of the river, and the ecological value of the river system.

The Committee noted that the review of the Waikanae Floodplain Management Plan was progressing and was the first of the floodplain management reviews on the western side of the region. It is proposed to use this as a model for the Otaki and Hutt Rivers.

Cr Laidlaw enquired as to whether GW and DoC were on the same wave length as far as climate change was concerned. Members were advised the GW takes the lead from the Minister for the Environment who are the body that collects the information and makes recommendations. This review was incorporating the advice of the Ministry regarding climate change.

Cr Buchanan indicated that this was the first review since the promulgation of the National Standard of Flood Risks. No implications were expected in relation to the Waikanae Floodplain Management Plan.

Members were advised that following the Wairarapa floods in October 2008 flood damage had occurred in a number of areas and a programme of repair works had been prepared. Council approval was required for the general rate funding from the Flood Contingency Reserves.

Cr Buchanan indicated that there had been very strong support and approval from the various Advisory Scheme Committee meetings and landowners on the allocation of their funds.

Members were given a brief summary of the issues discussed at the Wairarapa Hill Country Advisory Committee meeting held in December 2008.

Mr Gawith said that the Wairarapa Hill Country Advisory Committee supported Federated Farmers on seeking amendments to the rule on soil disturbance within the coastal environment management area. Mr Barton hoped that common sense would prevail as in some instances it was too restrictive and interfered with landowners seeking to run their own normal farm business. Cr Buchanan had informed the Wairarapa Hill Country Advisory Committee that this matter had been before the Council prior to the Committee being formed.

Mr Card hoped that everyone was being treated on the same basis and indicated that the South Island was a good example with NZED. He asked what GW staff were telling landowners regarding the emissions trading scheme.

Cr Buchanan told members that the proposed emissions trading scheme for NZ was on hold and under review in terms of its implementation. There was already in place a national market for carbon that can be accessed by farmers but there were risk profiles around this.

Mr Card considered that caveats were required about any information that comes from GW. Cr Buchanan indicated that it was logical for GW to be involved and said that there was a need for caveats around risk. There will be an ETS. Research was being undertaken on a practical basis and there may be a huge influence on land use. Farmers needed to be carefully advised.

Mr Gawith felt that consideration of the ETS on a farm by farm basis would sit better with the region.

Committee members were welcome to take the opportunity to attend the next meeting of the Wairarapa Hill Country Advisory Committee scheduled for 9 February 2009. Copies of the WHCAC Committee agenda were made available.

CM 101 Divisional Manager's Report

Mr Barton wished to raise his concerns about Canada Geese. He indicated that a significant report was being put together for the Minister of Conservation by DoC regarding the management of Canada Geese. Canada geese are a big issue for the Wairarapa and were spreading. Under Schedule 1 Fish & Game NZ have total control of Canada geese and under their Constitution must provide hunting opportunities. Mr Barton considered that GW did not appear to support changing to Schedule 5 which was disappointing.

Mr Card said that Canada geese were a supreme gaming bird that could travel long distances. The only answer to the problem was a very severe cull.

Mr Barton said that with Canada geese numbers having increased significantly in recent years there was a need to undertake massive culling. Further culling would only then be required periodically.

Cr Buchanan informed members that GW had been reluctant to become involved because of legal reasons but the Committee needed to be more informed.

Mr O'Donnell updated the Committee on the current Schedule 1 status with Canada geese being under Fish & Game's control. A plan and funding would be required by a management agency in order for a Schedule 3 status to be effective.

Mr Cameron reported on the Afforestation Grant Scheme and indicated that since the report was prepared staff were working with a further 5

landowners totalling 350 hectares in applications this year. Decisions will be made in March with a further round of applications in July.

Mr Gunn reported that total catchment management were pursuing the concept of five super catchments.

Cr Buchanan indicated that with regard to super catchments, discussions with the Regional Sustainability Committee would create opportunities in terms of the new regional plans. An integrated approach across the two committees would be required if the Council was to approve this direction. There was a preference to look at growing this region through TCM and how the integrated management of resources and community involvement is undertaken will quietly lead the country as to how our land is managed.

Cr Laidlaw said it was very encouraging with the biodiversity work being done and the movement towards a mega catchment approach.

Mr Card asked whether it would pay to put all resources into one catchment. Cr Buchanan said there is a need as a region to build the framework in which catchment management will work. The review of regional plans will provide an opportunity to work with our communities to develop the framework.

Cr Baber extended an invitation to members and staff to join the proposed Regional Sustainable Committee workshop.
