## **CDEM Group Appointments**

### **1. Purpose**

To enable the Wellington CDEM Group to appoint persons as required under the Civil Defence Emergency Management Act, 2002 (CDEM Act).

### **2. Background**

The CDEM Act (Sections 26 and 27) requires Civil Defence Emergency Management Groups (CDEM Groups) to officially appoint Group and Local Controllers (plus alternates).

In addition, the Wellington CDEM Group Plan (Part 5 – Administrative Arrangements) requires the Wellington CDEM Group to formally appoint Recovery Managers (and Alternates), Lifelines Co-ordinator (and Alternate), and the CDEM Group Welfare Manager.

### **3. Group appointments required in the CDEM Group Plan**

Appendix 4 of the Group Plan lists the statutory and non-statutory appointments made by the CDEM Group to give effect to its structural arrangements.

At its meeting of 4 November 2011 the CEG Sub Committee decided to recommend to the CDEM Group that Messrs Paul Nickalls and Mike Mendonca be appointed as interim additional Alternate Group Controllers for the Wellington CDEM Group until the new CDEM structure for the region is implemented. Both are well experienced Local Controllers and will strengthen the region's capability in addressing emergency events.

Hutt City Council has also decided to appoint Mr Matt Reid as their Alternate Controller and Recovery Manager.
