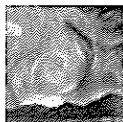
Hi Reina,

My apologies for the delay in responding to this query. After consultation it has been identified that there are some concerns with this proposal.

Managers of the Paekakariki camping ground which is a property of Ngāti Toa have requested that KCDC erect a substantial wooden fence along the boundary between the proposed park area and the camping ground. This is to ensure that the holiday park will not suffer adversely from more frequent use of the park in terms of security and privacy for guests. They have also requested further information about where the intended main access points to the park will be, will the main vehicle access be off Tilley Road? As the majority of cabins are situated along Wellington Road a substantial increase in road traffic here is undesirable.
